Some Elective subjects for Years 9 and 10 carry additional charges, therefore fees for some students in Years 9 and 10 will vary. These charges are added as an additional component of the February invoice.



Mount Carmel College aims to keep fees as inclusive as possible. We try to minimise additional payments that may be required throughout the year. Accordingly, tuition fees cover items such as the purchase and replacement of class textbooks which are loaned to students, classroom materials and consumables used in subjects such as Art, Technology, and Health & Physical Education (excluding the Learn to Swim program for Kinder to Year 6), camps (excluding interstate or overseas trips) and excursions, school competition entry fees, sports carnivals and training for school sports teams, co-curricular activities provided by the College, Feast Days, liturgies and thanksgiving masses and information and communication technology resources. There is no refund for activities that students do not attend during the year.

Exclusions & Additional Costs

In accordance with our Fees and Charges Guidelines and Fees and Charges Procedures, fees at each year level do not include interstate or overseas trips (with the exception of the Year 6 Canberra Trip) with the cost of these trips only determined closer to the time.

Booklists outline the required texts and stationery for full participation in learning programs. Students in Kindergarten, Prep and Year 1 will be provided with a pack of books and stationery from their class teacher. The costs associated with texts and stationery supplied by the College will be added as an additional component of the February invoice.

Literacy, numeracy and digital learning resources will be added as an additional component of the February invoice for students in Prep to Year 10.

Uniform costs vary depending on the year level. Full details on uniform costs can be found on the Uniform page on our website.

Family Discount

A family discount can be claimed on tuition fees when multiple children in the one family attend Tasmanian Catholic schools or Colleges, in accordance with the Catholic Education Commission Tasmania School Fees Assistance Policy.

The discount rate applied to each child is:

- 3 children 10% discount
- 4 children 20% discount
- 5 or more children 30% discount

If claiming the family discount, please provide details of siblings at Tasmanian Catholic schools or colleges other than Mount Carmel College. Enrolment may be verified with the listed schools or colleges.

The discount is applied to tuition fees only and is not applied to the enrolment fee, enrichment course charges for Years 9 and 10, interstate or overseas trips, IT levies or Capital Levy.

Fee Assistance

Fee assistance is available for families who anticipate or are experiencing financial difficulty. Please contact the Finance Officer at the College to discuss further.

Invoice Terms

Invoices are issued at the commencement of the new school year for the full year's fees and levies. Full payment is due 30 days from the date of the invoice, unless you have made alternative payment arrangements using the Payment Arrangement Form.

If you have not previously entered into a payment arrangement and would like to do so, please request a payment arrangement form from the College Office. Please note, even if you have previously entered into a payment arrangement in previous years, a new Master Payment Arrangement Form and Credit Card or Direct Debit authority must be completed each year.

Payment of the annual account by 31 March 2025 will attract a discount of \$100 per enrolled student. Interest on overdue fees is 10.00% per annum where applicable.

10 monthly installment accounts are sent out in the first week of each month. There is no refund for activities that students do not attend during the year.

Please note that any payment arrangement entered into is purely administrative. Notwithstanding the amount invoiced, in the event of default on payment arrangements the total amount outstanding will become immediately due. The school reserves its right to take steps to recover payment in full.
